

DECISION NO. 175 OF FEBRUARY 20, 2008

REGARDING THE ESTABLISHMENT FOR THE REGISTER TEMPLATES OF THE ASSETS DECLARATIONS AND THE REGISTER FOR THE INTERESTS DECLARATIONS

ISSUER: GOVERNMENT OF ROMANIA

PUBLISHED IN: OFFICIAL GAZETTE NO. 138 OF FEBRUARY 22, 2008

Under art. 108 of the Romanian Constitution, republished, and art. 10 point d) of Law no. 144/2007 on the establishment, organization and functioning of the National Integrity Agency, with subsequent amendments,

The Government of Romania adopts the present decision.

ART. 1

The Register model for the declarations of assets is approved, provided in annex no. 1 and the Register model for the declarations of interests provided in annex no. 2, which are integrated in the present decision.

ART. 2

(1) The Register for the declarations of assets will be made to size 210 x 297 mm, page orientation - landscape, and will contain 50 pages, respectively 100 pages, numbered from 1 to 50. The cover will be red and the text on the cover will be printed with white letters.

(2) The Register for the declarations of interests will be made to size 210 x 297 mm, page orientation - landscape, and will contain 50 pages, respectively 100 pages, numbered from 1 to 50. The cover is blue and the text on the cover will be printed with white letters.
